

CAHC ASSUMPTION OF RISK, RELEASE AND INDEMNIFICATION

PERTAINING TO PARTICIPATION IN CAHC TRAIL RIDES IN 2008

In consideration for CAHC permitting me to participate in the Trail Rides in 2008 , and by signing the entry blank, I agree as follows:

I AGREE that I choose to participate voluntarily in the Trail Rides, as a rider, owner, lessee, youth rider or as a parent or guardian of a youth rider. **I AM FULLY AWARE AND ACKNOWLEDGE THAT HORSE SPORTS AND PARTICIPATION IN THE TRAIL RIDES INVOLVE SERIOUS RISK OF HARM INCLUDING, BUT NOT LIMITED TO, RISKS OF ACCIDENT, SERIOUS BODILY INJURY, INCLUDING DEATH, BROKEN BONES, HEAD INJURIES, TRAUMA, PAIN, AND SUFFERING, AND PROPERTY DAMAGE. I ASSUME ALL RISKS OF HARM TO ME, MY HORSE OR MY PROPERTY.**

I AGREE for myself, my heirs, executors, administrators, successors and assigns to release CAHC, any Trail Ride, the facilities leased by the CAHC Trail Ride Committee and the owner(s) of the facilities, and all of their respective officers, officials, directors, employees, agents, personnel, volunteers, affiliated organizations and insurers (collectively, the "Released Parties") from any and all claims for damage, loss, or injury to myself, other persons, horses or other property belonging to me to the fullest extent permitted by law that arises out of or relates in any way to the Trail Ride and my participation in any Trail Ride INCLUDING, BUT NOT LIMITED TO, DAMAGES, LOSS, OR INJURY RESULTING FROM ANY ACTS, FAILURE TO ACT, NEGLIGENCE OR NEGLECT OF OTHER PARTICIPANTS, THE RELEASED PARTIES, THEIR CONTRACTORS OR INVITEES, as well as for theft, vandalism, fire, other casualty damage, or damage arising out of any defects in the premises or on the property.

I AGREE to indemnify and hold harmless (that is pay all losses, damages, attorneys fees and costs of) the Released Parties from and against any and all claims, demands, penalties, actions, losses, costs, damages, injuries, liabilities and obligations (including attorneys fee) of whatsoever kind and nature, which may be asserted against or incurred by any of them as a result of (1) my participation in any Trail Ride or (2) any act, failure to act, or neglect (a) by me or invitees, or (b) by any animal owned or ridden by me or in my custody or control.

By signing below as a parent or guardian of a youth rider, I consent to the child's participation and agree to all of the above provisions, and further agree to assume all of the obligations of the CAHC Assumption of Risk, Release and Indemnification personally and on behalf of the child.

This CAHC Assumption of Risk, Release and Indemnification is governed by the Laws of the State of Colorado and is intended to be interpreted as broadly as possible. I agree that exclusive jurisdiction and venue (place) for any legal action against CAHC, its officers, directors, employees, volunteers or agents shall be in the local district courts or the federal court of the State of Colorado. If any part of this agreement is determined to be unenforceable, all other parts shall remain in effect.
